CRITERIA:	RECOGNITION:
<ul style="list-style-type: none">• Achievement Award honors an individual who has contributed to the success of the hazard recognition program through having successfully recognized and reported current and potential hazards, serving on the hazard recognition committee, completing safety walks and assessments.• Outstanding Service Award recognizes an individual who has been instrumental in making a safer work environment through actively participation in the following:<ul style="list-style-type: none">○ Education of employees on recognizing hazards.○ Maintaining a system for employees to report hazards.○ Maintaining a system to acknowledge employee participation and engagement in the program.• Eligibility is determined based on self-reported data submitted by the participant. Any organization recording a fatality will be disqualified.• Application must be submitted by the individual's supervisor or corporate safety manager.	<ul style="list-style-type: none">• Qualified companies, locations or divisions can purchase an Individual Hazard Recognition Award to commemorate their employee's achievement.• <u>Pricing:</u> Engraved Plaque \$79.95 Engraved Crystal \$149.95 (plus shipping, handling and applicable tax).
